<p>4. Minutes of the 2023 AGM</p>	<p>Motion That the minutes of the 2023 AGM be accepted as a true and accurate record. Moved: Elizabeth Synnot Seconded: Philippa van Kuilenburg Passed</p> <p>Matters Arising from the Minutes : Affiliates Review Potted history, not looking for a decision, instead make visible the breadth of thinking around this topic.</p> <p>Reference made to Affiliates review discussion paper on website. Lay out three options:</p> <ol style="list-style-type: none"> 1. Status quo; 2. Affiliates to be added as a category in the Constitution (S 4.1); and 3. Something outside of membership for example "Friends of AANZPA". <p>Charmaine offered 4th option, affiliates meet some criteria, like Associates, in order to meet membership code of ethics requirement, eg. Supervisory relationship.</p> <p>General Discussion</p> <ul style="list-style-type: none"> • Affiliates want to contribute to Regions • Complaint Procedure doesn't exist for affiliates • Being bound to Code of Ethics, choice of words is legal, and how would that work? • Judy Sutherland. Key issue is being covered by a complaints procedure and ongoing relationship with training bodies. The Ethics Committee has not received a formal complaint yet which is a desirable position. • Jenny Hutt. "Friends of", the sense of belonging is captured. From the perspective of a training body, we don't want to increase workload to meet a membership criteria simply for belonging. • Patricia O'Rourke. Professional association is important to AANZPA. • Clarification. You can't be an Affiliate without being an Associate first. • Affiliates can be contributing through delegation by others. • Bev Hosking. How we function together is an important consideration. • Charmaine. When Affiliates hold positions on regional committees, is there no mechanism for complaint? • Hamish answered 'No'. Described difference in relationship between Ordinary and Associate members with their Supervisor. Willingness to discuss conduct, and some are not willing. • Neil Simmons. "Friends of" definition? What do you get from that? How would that be different from an Affiliate? • Annie Fisher. Past experiences showed that the "Friends" option was not ok. • Danielle Forer. The article about equivalency in the most recent Journal was informative. Clarification of equivalency process, category of "Candidate" involved looking at criteria to enable transition to either Associate or Ordinary member.

- Saskia Dickson. As an active Affiliate, she wants to stay involved, but doesn't want to have supervision. Her sense of belonging was harmed by reclassification to Affiliate. While her passion for psychodrama is not reduced, her passion for AANZPA has.
- Issue of more voices from Affiliates themselves.
- Jen Callanan. "Friends of ", warmup is increased when there is greater involvement, and vision of AANZPA is enlivened.
- Bev Hosking. Some Affiliates positively choose this category, eg. Glenis Levack, loves being an Affiliate.
- Jenny McIntosh. As a simple soul it's quite clear, if you're practising you need to be covered by a process for complaints. Being an Associate means commitment to training and abiding by ethics and being supported in regard to complaints. Nothing to stop Affiliates practising psychodrama but need to be clear that unless they're involved in the professional development in the Association, they must be covered. We want their support. Perhaps they could have their own indemnity.
- Peter Howie. AANZPA could consider a "Patreon" group. They pay a little and can be part of the Association. (Tongue in cheek.)
- Diz Synnot. Need another line in the Constitution, in order to cover Affiliates as a category of membership.
- Liz Marks. Helpful to find a way to enable Affiliates to contribute in Regions as that's where it's mostly happening. And not clear, what work an Affiliate would need to do if a complaint process happened.
- Bev Hosking. Regarding the Constitution, there is provision to create sub-category, it doesn't need to be named but there is freedom to create it.
- Diz Synnot. I would want the category protected.
- Don Reekie. Vision from earlier times. "Affiliates" turned down 1983, but it returned. "Friends in Regions" sounds ok.
- Hamish Brown. "Friends" category could be a good idea. We could invite Jacinda Ardern.
- Ali Watersong. Clarification, what would the subscription be for those who are interested in psychodrama but not AANZPA? As was the case with the category "mailing list".
- Kevin Franklin. WA region is struggling for membership. He likes the idea that is being considered and Jenny Hutt's comment. Function & Structure are being thrown into confusion. For example, we don't want "Friends" to come to this conference because it's primarily training and professional development. Whereas in regions we want "Friends" in developing a community. Useful that trainers are involved in the practice of psychodrama in the regions, as they promote psychodrama and spontaneity, etc.
- Kate Cooke. Broader changes are happening in the Association. There are more Ordinary members than trainees (Associates). There are more practitioners who are not Trainers and who still want to learn through opportunities for continuing professional development. Words create exclusion, hence attention to language is important. "Friends" term resolves the dilemma that the Affiliates category creates.

Cissy summarised some themes in the discussion, eg. Affiliates adding to the life of the regions, eg. public perception of membership and its significance. End of discussion.

Membership for IAGP

Letter from IAGP President Heloise, presented by Kate Cooke.

Considerations for AANZPA to join or not.

Anyone can join and attend their meetings on an individual basis and this has already happened, eg. Peter Howie, Charmaine McVea, Simon McLelland. Carlos Raimondo's organisation *Active Learning International*, is the only other Affiliate member in Australasia. The cost is \$400 US.

Arguments **FOR** joining:

AANZPA has had a representative there before and it was good to have a presence in that organisation, there were real benefits.

Good to mix with other practitioners and other models (eg psychoanalysis), and gain cross cultural perspectives.

Benefits of being part of a larger community.

Benefits of being part of outreach work to countries like Africa and India where these things are unaffordable but very worthwhile.

Synergy in aims of IAGP and AANZPA (Cissy Rock style), group work and organisational focus.

Joining and experiencing one conference will clarify the benefits.

Simon McLelland described his experience in their board as "exuberating" and he encouraged others to join.

This is the first time our membership with IAGP has lapsed.

Arguments **AGAINST** joining:

There was no monetary benefit in the past when AANZPA joined IAGP.

There is no reduced fee for individual members of AANZPA joining or attending IAGP events if our association joins IAGP.

Budget considerations at this time, we are trying to recover an overall deficit.

Actual cost depends on conversion rate against the US dollar.

What else could our money be spent on? What's of real value here?

The Representative would have additional costs which AANZPA does not meet.

Motion.

AANZPA to join IAGP for 1 year to be reviewed at the next AGM.

Diz Synnot, amendment. Next time go for 5 years and really be intentional for our aims.

Not accepted by Don as proposer of motion.

Vote: Yes = 30, No = 14, Abstain = 7.

Passed. It is the Exec's responsibility to appoint a representative of AANZPA. Exec will communicate their decision via Express.

New item. Future Conferences

- Idea of two alternating set venues, one in NZ and one in Australia.
- Creates known costs, amenities, budgets etc.
- Decreases workload of regions doing it once or occasionally.
- Involves building relationships with people in specific venues, despite changes in staffing.
- Committees could be national rather than current practice of regional.
- Mechanism in Exec related to those committees.
- Perhaps starting from 2026.
- Cissy and Simon are forming a working group to look at options, advice etc.
- Expressions of interest are asked of the membership.
- 2021 Conference is an example of members from both countries working together.

New item. Executive Committee membership.

- Invitation to warm up to the idea of joining the Exec. The next Executive election will be held at the 2025 AGM in Dunedin.

New item. Marketing.

- Question from Peter Howie regarding a report written previously on marketing.
- Website issue. Finding names of people, you had to log in. If someone ordinary was looking for local psychodrama practitioners or events, the current website wouldn't help.
- Cissy will respond to the question about the previous report at a later time.

Discussion

- General support for promoting psychodrama to the public.
- AANZPA website can be a key instrument of marketing.
- Practitioners can be identified and their location.
- Some resistance to the language of "Marketing".
- (Approx) 2014 investigation revealed a large expanse of connections of AANZPA members to other sectors. Sociometric wealth is not being utilised.

- eg. Practitioners who inhabit spaces at Universities.
- eg. Members who have a strong media presence.
- Differentiate promotion from training, ie. improve access to experiences of psychodrama. Training institutes, what process to attract trainees?
- Is the website fit for purpose?
- Invitation to join a working party on promotion of psychodrama.
- Some regions are active in promoting psychodrama:
 - NSW.
 - Victoria aims to have a website to promote new initiatives by members.
 - Christchurch, 'Enliven' brings spontaneity into the community.
- Marketing, think of the need. Pandemic has created need, running groups would meet this.
- Is it OK to promote in the community as an individual? Good to get permission from this proposed subcommittee.
- Sense that this motion will answer the question 'where are the young people in psychodrama?'
- Governance structure requires that the Subcommittee reports to the Exec. Motion needs to be refined.

Motion. That the Exec will create a subcommittee of AANZPA for marketing. In order to market the objectives of this Association promote psychodrama, sociodrama, role training etc. To report back in 2 years.

Comments and Context

- Who are we? Charmaine McVea, Cher Williscroft and Rollo Browne.
- The functions of the Board of Examiners are:
 - to establish and enhance the continued development of standards of training, and of practice;
 - to establish standards for and accredit training institutes; and
 - to establish and conduct examinations and certify practitioners and TEPs.
- The two training institutes are Psychodrama Aotearoa New Zealand (PANZ) and Psychodrama Australia (PA).
- The production of theses stands independently of the Board of Examiners.
- The Board of Examiners reviews the training institutes.
- A snapshot:
 - 154 trainees across Australia and New Zealand.
 - 8 are developing their specialist paper.
 - The term 'practicum' is more accurate as it marks a shift in identity from trainee towards practitioner.
 - 9 are working on their theses and 3 theses have been passed.
 - Involves development and integration
 - Identity of the practitioner is illuminated to themselves and others.
- Issue of supervision.
- Developments in the training institutes.
 - responses to emerging trends and ongoing training needs to become Psychotherapists.
 - PANZ application to PBANZ, to become a registered training provider.
 - PA working with PACFA, to recognise AANZPA Ordinary Practitioners.
- PANZ first year as a national institute with a national training programme.
- PA update on campuses in Perth, Melbourne, Brisbane, Canberra, Sydney.
- Most of the work done by PA and PANZ faculty is voluntary and "a gift from the heart". The Board appreciates this enormous contribution.
- Staff changes
 - Judith McDonald, TEPit based in the Dunedin Ōtepoti Campus of PANZ.
 - Walter Logeman, has resigned from PANZ Ōtautahi Christchurch Campus. Trainer since 2007, TEP since 2014, distinguished member 2013, BoE member for a time.

- Peter This is not a practitioner Ordinary member issue, it's the issue of training bodies. Worried we're becoming a training association. I'm clear that as AANZPA we review the standards that others set.
- Don. Many reasons why people in their region struggle with training. Some of it is to do with writing. It's important to assess the integration. Maybe thesis is not the right way, not to stop producing theses but could be other writing.
- Kevin . Trusting Don is riding a wave of intuition. Fears putting any individual in front of a wave of hate as a result of his book being published. Anticipates intense scrutiny, and are we up for it?
- Desley C. Deconstruction of society is coming. Sees an inclusiveness issue here, this institute is patriarchal, it's too white.

Less than 50%

- Already always reviewing, who will do the work of this review?
- Jenny Hutt. This motion is a solution to something that hasn't been analysed sufficiently. Letter from Christchurch region had a lot of blind spots, assumptions. Of the 5 points, one saying no curriculum, it's bullshit. Many have trained in psychodrama, don't see it as a failing that some have not certified. It's not a measure of our success. Despite all the investment, love, people come up against painful experiences. Meeting the requirements can be moved against unconsciously. Writing allows a window into what that person is doing in applying the method, as one aspect of the assessment. Incandescence of their theses writing.

Great that practitioners are doing exciting things, taking initiative, that's the real life of the future. It's one area of review which the Exec is already doing to nourish this in the regions. When review goes in the direction of training, it misses focus on AANZPA. A lot of stuff there (in training) doesn't need formal review. ● Diana. As an organisational person, it's frustrating that the purpose is unclear. Question to Don - what outcome do you want? I'm standing at 20% because it's unclear what you want. I'm not interested in open exploration. In practice, reviews don't get done in many organisations. ● Cissy. Very keen to get the involvement of all. And lots of people are already doing a lot of work. ● Bernie. Less with training, more to do with organisational reviews, only seen a couple where review outcomes have not gone ahead. As an Association and as regions we're in a place where we can do that, and sustain trainees, members. Not a 2 year review, but a review. ● Hamish. Relate to Jenny Hutt's comments. From PBANZ view, lots (of trainees in other training programmes) don't complete training. Focussed areas for dialogue would be the middle (of the continuum). <p>Cissy. Time for vote Don. Thanks for the discussion, not helpful to take a vote at this time. Cissy's work this year shows reviewing is happening.</p>
